Reminder - Extension of the School Day

Before we broke up for the summer holidays, we wrote to let you know about the slight change we have had to make to our school day, to ensure that we are following government guidelines.


In the mornings, the school gates will still be open at 8.30am and close at 8.40am, to take the register at this point. The main change will be at the end of the school day, where the children will now be released at 3.10am. We will open the school gates at 3.05pm to give you time to make your way to your child's classroom. The gates will then be closed at 3.15pm.



Reminder - Entrance and Exit Gates

Below is a map showing your choice of entrances and exits. The only change this year is that we will be opening the small gate, next to the Y3 classrooms, instead of the double car park gates. If using this entrance, please access it by walking through the main office gates and past the kitchen and not through the car park.

Whichever entrance/exit is most convenient to you can be used, when dropping off and collecting your children each day. We only ask that for health and safety reasons, you do not park on the yellow lines, in front of the school or in the staff car park, unless you have a pre-arranged agreement with the school.





<u>Attendance</u>

Attendance Matters



For a child to reach their full educational achievement a high level of school attendance is essential. We are committed to providing an education of the highest quality for all our children and we endeavour to provide an environment in which all pupils feel valued, safe and welcome. Parents and children play an important part in making our schools successful. Every child has a right to access the education to which they are entitled. Parents

and teachers share the responsibility for supporting and promoting excellent school attendance and punctuality for all.


For our children to take full advantage of the educational opportunities offered it is vital your child is at school, <u>on time, every day</u> the school is open, unless the reason for the absence is unavoidable. The routines children develop around attendance and punctuality at school are the same as the expectations of any future employer in the world of work. High attainment, confidence with peers and staff, and future aspirations, all depend on good attendance.

Good attendance is important because:

- statistics show a direct link between under-achievement and absence below 95%
- regular attenders make better progress, both socially and academically
- regular attenders find school routines, school work and friendships easier to cope with
- regular attenders are more successful in transferring between primary school, secondary school, and higher education, employment or training.

Responsibilities of parents and carers

Ensuring your child's regular attendance at school is a parent/carer's legal responsibility (section 444 of the 1996 Education Act) and permitting absence from school that is not authorised by the school creates an offence in law.



Our attendance ladder clearly shows what we expect in terms of good attendance at school, and our policy informs you further of what happens when attendance falls below certain levels. You can find a copy of our policy on the <u>website</u>.

In summary, if your child's attendance falls below 90%, you will receive a letter to alert you of this and when we feel it is necessary, home visits will also be arranged. If your child's attendance falls below 96%, we will require evidence to authorise any further absence. Holidays will not be authorised.

Lateness also affects your child's attendance so please try to ensure that your child arrives at school before the gates



close, each morning at 8.40am. You can check your child's current attendance using the 'My Child at School App'.

Parents and carers must:

- inform the school on the first day of absence
- be clear about the reason for the absence to enable us to determine if the absence will be authorised
- inform school of any unavoidable planned absences well in advance
- support the school with their child in aiming for 100% attendance each year
- make sure that any absence is clearly accounted for by telephone or email on subsequent days of absence, or by letter if a phone is unavailable
- avoid taking their child out of school for non-urgent medical or dental appointments
- only request leave of absence if it is for an exceptional circumstance.

School Uniform

Here is a reminder of our approach to school uniform. Full information can be found on our website using this link <u>Cann Hall Primary School - Uniform (compassps.uk)</u> Please note there are a few small changes, which have been highlighted in blue.

Uniform Requirements:

- Red gingham dresses
- School grey skirts/trousers/pinafore dresses of appropriate length, no leggings
- Red polo shirt
- Navy sweatshirts/cardigans (no hoodies)
- White socks/grey tights
- School grey or black trousers (short or long)
- Red polo shirts
- Navy sweat shirts
- Black/grey socks
- No 'skins' to be worn underneath school uniform.

FOOTWEAR:

We ask that all children wear sensible black shoes, **boots or black trainers**. Any other trainers, baseball boots and light-weight canvas shoes of any colour are unacceptable, along with sandals. Wellington Boots may be worn in wet weather, but please ensure that your child has another pair of shoes to change into on arrival at school.

PHYSICAL EDUCATION & SPORTS:

School PE kits, as stated below, should be worn to school on your child's PE days with a school jumper or cardigan.

- 1. Black plimsolls or trainers, (preferably with elastic fronts rather than laces for infant children)
- 2. Plain red T-shirt, or logo T-shirts (available at the office)
- 3. Black shorts- no leggings
- 4. Plain grey or black tracksuit for colder weather



Children are not permitted (in line with Health & Safety guidelines) to wear earrings for PE and these must be removed by the child.





Pupil Premium Entitlement

All Foundation Stage and Key Stage 1 children are entitled to Universal Free School Meals, so for the first few years of their school life, school meals are free. As well as this, families who receive certain benefits may be eligible for additional funding called **Pupil Premium**, which is used to support the children in school academically, towards trips, school uniform and clubs.

Your child would be eligible for this funding, if you receive any of the following benefits:

- Universal credit with an annual income of no more than £7,400 (after tax and before benefits)
- Income Support
- Income-based Jobseeker's Allowance
- Income-related Employment and Support Allowance
- Support under Part 6 of the Immigration and Asylum Act 1999
- The guarantee element of Pension Credit
- Working Tax Credit run-on (paid for the four weeks after you stop qualifying for Working Tax Credit)
- Child Tax Credit (with no Working Tax Credit) with an annual income of no more than $\pounds 16,190$

If you think your child could be eligible for this additional funding, please do contact the school office and we will be very happy to help you with the application form.

Healthy Snacks

You are very welcome to send your child into school each day with a 'healthy snack' for them to eat at break time and we encourage you to send them in everyday with a drink of water or sugar free squash (no glass bottles).



Please see below the acceptable healthy snacks which have been agreed on as a school:

- plain biscuits, for example, rich tea, digestives
- breadsticks
- fruit (fresh or dried)
- vegetable or salad sticks
- plain rice cakes
- plain crackers

Children in EYFS – Y2 receive a weekly delivery of fresh fruit or vegetables, which they are offered at snack time, each day.



School Dinner Payment

If your child is in Years 3-6, you would like them to receive a school meal and they are not eligible to Pupil Premium, please ensure that there is sufficient credit in their dinner account, which is accessed through your **'My Child at School'** app. If you have any problems with this, please pop into the office and we will be happy to help.


Please be assured that we have the appropriate insurances in
